

## NON RESIDENTS LIBERIAN BANK ACCOUNTS OVERVIEW

### ACCOUNT TYPES

- NRL CURRENT ACCOUNT
- NRL SAVINGS ACCOUNT

### REQUIREMENTS

- Must be a legal resident of country of residence, with valid and current residence permit;
- Account opening package duly completed & signed;
- Two recent passport photographs (2 copies per signatory);
- Valid ID Card- Driver's License or International Passport or Residence Permit or Work Permit (necessary to confirm customer's status)
- Proof of address (current utility bill not exceeding 2 months or last 6 months bank statement)
- Proof of source of funds (Employer's Reference or Letter of Employment or Work ID or Recent Payslip or Evidence of Business Registration, Business bank statements or Banker's Business reference;
- Attestation of passport and photocopies of attached documents (2 to 5) by a NOTARY PUBLIC or THE LIBERIAN EMBASSY or UBA NRL BANKING CENTER STAFF. Attesting Officer should include Name, Address, Contact, Phone Number and Email Address.
- Completed Indemnity Form
